

Authors' Checklist for Manuscripts for Submission

(Reference to *Regulations on Submission to Agricultural Information Research, Instructions for Authors, The Japanese Society of Agricultural Informatics Copyright Regulations, and Detailed Regulations on the Japanese Society of Agricultural Informatics Copyright Regulations*)

- [] Submission fee and excessive page fee are collected for manuscript that has been accepted for publication.
- [] The author(s) will be asked to transfer copyright upon acceptance of the manuscript.
- [] The manuscripts are submitted on A4-size paper, horizontally written in vertically oriented characters, with a margin of approximately 3 cm left on all sides, approximately 40 lines, with line numbers and page numbers included on every page.
- [] All titles are not numbered. Titles for "Introduction," "Materials and Methodology," "Results and discussion," etc., may be used freely, but are not assigned numbers.
- [] The manuscript include three page layouts—*title page, body text page, and figures and tables page.*
- [] The abstract provides a concise description of the content of the main body of the document in around 300 words. The keywords describe the core of the thesis in six words.
- [] The title has capital letters for its first letter and for the first letter of nouns, verbs, adjectives, and adverbs.
- [] The names of authors are written in order of given name and family name (with the first letter capitalized and the second letter thereafter in lower-case letters). Co-author(s) is(are) connected to the name of the primary author with "," (commas), and an "and" instead of a comma before the name of the last co-author.
- [] If co-authors are affiliated with different organizations, 1) and 2) are listed to the right of the authors' names.
- [] One author is defined as the Corresponding Author, denoted by an asterisk to the right of the author's name. The manuscript lists the Corresponding Author's contact details (at least one e-mail address, phone number, or fax number).
- [] The list of references should be listed in alphabetical order.
- [] In the list of references, for sole authors, the name is written family name first, followed by the author's name, with the first letter of the family name capitalized and the other letters in lower case, with "," attached, with the first letter of the given name capitalized, followed by "." When writing the names of multiple authors, the names of the authors from the second author onward are written in the order given name followed by family name, with the names of authors separated by a comma, and an "and" instead of a comma before the last author's name.
- [] For literature quoted within the main text, when listing the names of two co-authors, the family names are listed in sequence, joined with an "and." When there are three or more co-authors, the citation lists only the first author's name of those cited, followed by "et al."
- [] The citation methods are used for URLs based on those used for normal literature.
- [] The figure/table sizes, titles, and explanations are created in such a way that they fit on a single sheet of A4-size paper.
- [] The figures/tables are listed with titles such as "Table 1" and "Table 2" or "Fig.1" and "Fig.2" and arrayed in order of those numbers.
- [] The approximate locations where diagrams are to be inserted are marked in the margin to the right of the text.
- [] The manuscript submitted by non-native English speakers is proofread by a native English speaker.
